

## Information pursuant to General Regulations No. 679/2016 (Privacy Regulation)

Pursuant to art. 13 of Regulation No. 679/2016 (the "Privacy Regulation"), as an interested party, we inform you that the processing of your personal data by Saga Srl (hereinafter "Data Controller") will take place in compliance with its own Privacy Policy, and in accordance with current legislation on the protection of personal data. Pursuant to the Privacy Regulations, the Data Controller is the Company Saga Srl, with registered office in Colonnella (TE), Contrada San Giovanni 75, ITALY in the person of its pro tempore legal representative, electively domiciled, for the provisions of the Regulations, at the headquarters of the writing and that can be contacted for the purposes of the same Regulation to the e-mail address [privacy@sagacontract.it](mailto:privacy@sagacontract.it). The processing of your personal data is carried out to respond to your request for information and for sending commercial and promotional communications (including telematic methods), it is understood that your data will not be disclosed outside the structure of the Data Controller . The provision of your personal data is necessary for the functional processing to send the requested information, a possible refusal would prevent us from providing you with the required information, while it is optional for marketing purposes. Your personal data may be collected and processed also by means of cookies and other interactive technologies. For more information on cookies and other interactive technologies and how to disable them, please read the appropriate Cookie Policy. The processing of your personal data, performed for the purposes specified above, is carried out using computer and manual means, in compliance with current security regulations. The processing operations are carried out minimizing the use of personal and identifying data not necessary for the specific purposes of treatment pursued. Your personal data will be accessible within the Organization of the Data Controller exclusively to persons who need to know them because of their duties with respect to the processing purposes specified in this Information, as Authorized Persons for processing and, where appointed , to the Data Processors. The complete and updated list of the appointed Data Processors will remain at your disposal at the Owner, and will be sent to you on request. The Data may be disclosed to public bodies, authorities or institutions, as well as to anyone who is legitimate recipient of communications required by law or regulation; these subjects will process your personal data as Owners or Managers, depending on the case. Your personal data will in no case be disclosed to third parties for promotional purposes and will not be disseminated in any way, nor will they be transferred to any foreign country or international organizations. The Data Controller records that, in relation to the processing of the sending of the information requested by you, it is necessary to express a specific Consensus on your part. For the compulsory communication to the categories of subjects indicated above, however, no consent is required from you, provided that the same treatment is carried out in compliance with the law. The Data Controller informs you that, as an Interested party, you have all the rights provided for by the Rules: art. 15 (Right of Access), art. 16 (Right of Rectification), art. 17 (Right to Cancellation), art. 18 (Right of Limitation of treatment), art. 20 (Right to data portability), art. 21 (Right of Opposition). You also have the right to revoke at any time the consent given to the processing of data, the Revocation takes effect from the moment we become aware of it and does not affect the lawfulness of the treatment based on the consent previously given. Finally, you have the right to lodge a complaint with a Supervisory Authority. In all the cases described, the exercise of your rights will be brought to the attention of those to whom the Data have been communicated, except for the exemptions provided for by the Regulations. In some cases (cancellation, limitation, opposition) the exercise of your rights may not make it possible, in whole or in part, the provision of services and / or services in your favor.
